Journal Article with DOI (direct object identifier) and Continuous Pagination. With continuous pagination, only the first issue of the volume has a page 1. If there is a letter as part of the pagination, leave the letter in the citation. Adler, Epel, Castellazzo, and Ickovics (2000) and Lam, Hiscock, and Wake (2003) have continuous pagination. Lam et al. (2003) has a letter as part of the pagination. If the journal repaginates each issue, leave the issue number(s) in the citation. See Pressman; issue 3-4 is part of the citation. These three citations with the DOI indicate that the researcher viewed the journal article electronically.
