## Giving Our History a Home: African-American Women in Iowa Project

There's cause to celebrate at the Iowa Women's Archives. Our project to document the lives and experiences of African-American women in Iowa has gotten off to a promising start. Launched with a program, reception, and exhibit at the University of Iowa Libraries last December, the project to collect the personal papers and organizational records of Iowa's African-American women preserves a largely unexplored area of Iowa history.

An advisory board has been appointed to guide project director Kathryn Neal in her efforts, but she also needs your help. There are women throughout the state—both prominent and private—with stories and materials to be saved. Please help us find the letters, diaries, speeches, scrapbooks, audio or video tapes, church bulletins, and other material tucked away in closets and cabinets at home. We also seek the minutes, memoranda, annual reports, and subject files that make up the records of African-American women's organizations.

Besides visiting with possible donors individually, Neal talks to clubs, organizations, and other groups about the project. If you have questions contact Neal at (319) 335-5068 or by e-mail:

## Research in the Archives

Two graduate students, including one from University of California, Davis, are currently conducting dissertation research in the archives. One is focusing on the Equal Rights Amendment campaigns in Iowa and the other on the Association for Intercollegiate Athletics for Women.

Thirty-six students from Mount Pleasant High School came to use the Peg Mullen papers as part of their American History unit on Vietnam.

Fifteen women prominent in the political affairs of their countries toured the IWA while visiting the United States under the auspices of the Iowa Council for International Understanding (April 1996).

## Here and There in Iowa

Judge Rosemary Sackett held a buffet supper at her home in Okoboji to introduce assistant archivist Tammy Lau and curator Karen Mason to potential donors in the area (October 1995).

Assistant archivist Kathryn Neal spoke at the Rosa Parks Day Celebration at Iowa State University (February 1996).

Lau and Neal gave a talk entitled "A Patchwork of Voices: Iowa Women and the Iowa Women's Archives" at the Beyond Rubies Conference at Kirkwood Community College in Cedar Rapids (March 1996).

## Exhibition

Our next exhibition features **Eve Drewelowe**, a painter who in 1924 became the first person to receive a graduate degree in art from the University of Iowa. Eve Drewelowe bequeathed an extensive collection of her paintings and her papers to the University of Iowa. The exhibition is being designed by Monica DeMott, who recently completed her MA thesis in the University's School of Art and Art History entitled: "Eve Drewelowe: Transformations Within Her Life and Work."
